CITY OF PINE LAKE CITY COUNCIL MEETING MINUTES MARCH 12, 2018 7:00 PM

Call to order

The meeting was called to order at 7:00 pm by Mayor Pro-Tem Jean Bordeaux. Also present were Council members Megan Pulsts, Augusta Woods, Brandy Hall and Kris Casariego and City Administrator Valerie Caldwell. Mayor Melanie Hammet, Chief Sarai Green and the City Attorney were not present.

Pledge of Allegiance was led by Bordeaux.

Announcements/Communication

- Woods announced that she attended the Government's Meeting last week and Carl Vinson Institute presented information on data research regarding annexation and the impacts new cities will have within county government and services. A steering committee will be established.
- Bordeaux announced that she and Woods attended the PRISM (Pride Rings In Stone Mountain) Meeting last week at St. Timothy. The purpose was membership and community organization and meet once per month.
- Hall announced that on Saturday, March 17th they will be leading Pocket Parks. She
 attended the DeKalb Watershed Steering Committee meeting and that there is a form
 to be completed about the needs of the city. Hall communicated that The Bee City
 USA application has been submitted for the city.
- Bordeaux communicated that DeKalb County Sewerage has been working on manholes near her house and asked if it was normal maintenance. Caldwell stated that they are operating under a consent decree by the court and must make emergency maintenance and clean up and until their model is approved by EPD and that everyone must obtain approval for sewer capacity letters before building. She also stated that the next section of maintenance will be down by the beach house.
- Casariego communicated that she met with Bordeaux and resident Wonda Cooley last regarding the website and interfacing with social media. She said that she will present a layout for a city Facebook page to include what needs to be look at and for the best use of the page. Casariego's plan is to have this information to council by the end of March. The page will also serve as an educational tool for the city matters.
