# CITY OF PINE LAKE CITY COUNCIL MEETING MINUTES MARCH 27, 2018 7:00 PM

#### Call to order

The meeting was called to order by Mayor Melanie Hammet at 7:01 pm. Present were Mayor Hammet, Council members Jean Bordeaux, Kris Casariego, Brandy Hall, Megan Pulsts and Augusta Woods. Chief Sarai Y'Hudah-Green, Administrator Caldwell were also present.

#### Announcements/Communication

- Hall announced that:
   Caldwell would be the liaison for Bee City USA designation.
   She and a group of kids had participated in poison ivy removal.
- Woods announced that: She and Bordeaux will attend the State of the County and DeKalb Municipal Association meetings this week.
- Bordeaux announced that the website would convert over and go live on March 28<sup>th.</sup> The project list for the city will be on the site. A social media policy and user guide will be established for posting on the website.
- Casariego communicated that:
   She has a strategy for launching a city Facebook page but that the social media policy was needed first and will do additional research.
  - That Public Works @ Public Works Project is getting kicked off and Wanda Colley is assisting with the coordination for submission of the art. # **MEMORANDUM OF UNDERSTANDING**

This constitutes a Memorandum of Understanding between the City of Pine Lake (Sponsor) and the Pine Lake City Arts (Organizers of LakeFest) regarding LakeFest 2017 to be held on October 7 and 8, 2017. Each party agrees to the following stipulations:

#### The City of Pine Lake will:

- MAKE the Beach House available to LakeFest organizers from Thursday evening, October 5 (if there are no rentals) to Tuesday, October 10 at noon. If there is a rental on Thursday evening, the beach house will be available at 8:00 am on Friday, October 6
- NOT MAKE AVAILABLE any chairs or tables stored at the Clubhouse.
- ALLOW public works to provide logistical support to LakeFest on Friday during their regular work hours at no additional charge.
- CLOSE Lakeshore Drive between Magnolia and Spring Street for the festival.

#### Pine Lake City Arts will:

- PAY \$1,200 to the City for facilities rental for LakeFest.
- **PROVIDE** to the City a sponsorship valued at \$707.00 and publicize the City as a sponsor on all promotional materials and printed matter.
- COLLECT and BAG all trash on a periodic basis sufficient to ensure no overflows of trash from
  trash containers. BRING all collected and bagged trash to the City dump truck. No staff person
  will be available to drive the dump truck and no other person is permitted to drive the vehicle.
- **CHECK** with and get the permission of property owners before erecting one single banner on Rockbridge advertising LakeFest.
- NOT erect flag or feather banners per City ordinance of any type or for any purpose.
- To the extent not covered by this Memorandum of Understanding, WILL comply with all other conditions for rental or use of City facilities.
