COVID-19 Update: Hammet stated that the city shows a tremendous number in mask wearing and that the state's numbers from July 4th are alarming. The Mayor said that DMA is negotiating with the County for funding for cities that Governor Kemp has released for COVID-19.

Beavers stated that the food pantry has been positive and has received \$1,400 in donations, served 10 families and delivered 48 food kits.
